AN ORDINANCE AUTHORIZING A CHANGE OF ZONING CLASSIFICATION FROM R-1 FO A-1 FOR THE PROPERTY LOCATED AT 1.5 ACRES OF LAND ON THE SOUTHSIDE OF CASH LANE BEHIND 103 & 107 S OAK STREET, COLE CAMP, MISSOURI
WHEREAS James & Nancy Theisen applied for a Rezoning Request on August 6, 2024 for the burpose of storage of personal property within the City of Cole Camp, Missouri, requesting a change from R-1 to A-1; and
WHEREAS in accordance with, Sections 405.070, Section 405.080 and 405.090 of the Cole Camp Zoning Code, public notice has been given for the Rezoning request through: 1) the publication of a Public Hearing advertisement in a paper of general circulation, 2) the notification of adjacent property owners, and 3) the posting of a sign on the subject property; and
WHEREAS a Public Hearing was held on September 10, 2024 by the Planning and Zoning Commission regarding the Rezoning request by James & Nancy Theisen; and
WHEREAS following the Public Hearing by the Planning and Zoning Commission and after consideration of the request and testimony presented therein, the Planning and Zoning Commission finds it is in the public interest to approve the Rezoning request; and
WHEREAS The Board of Aldermen of the City of Cole Camp hereby adopts the Planning and Zoning Recommendation.
NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF COLE CAMP, MISSOURI AS FOLLOWS:
Section One
Exhibit A, Property Description, is hereby approved for the zoning designation of A-1.
Pursuant to the provisions of the Cole Camp City Code, the Board of Aldermen hereby approves a rezoning request to allow for a change from R-1 to A-1.
