Police Report: Chief Canfield gave the council information about the Solid Waste Ordinance and the time the trash cans are set out and when trash cans are put away. The city will bring an ordinance to the council updating the Solid Waste Ordinance for setting out trash cans the day preceding trash pickup at 8:00 A.M and putting trash cans away by 8:00 A.M. the day following trash pickup. The police department has applied for a grant for equipment for a 4th full-time officer. Durango #2 is still waiting on the center console. Number of Reports in 2023 was 185, Number of summonses 110, Number of vehicle stops 243.

Mayor Report: The mayor talked about the Point System for uniforms for Officers. The amount would be almost \$200 a year or 7.75 points per pay period. The point system would give the police employee the ability to purchase his own equipment/clothes/boots. Jon Beckman motions to go with the point system for law enforcement only at 7.75 points per pay period with a second from Mindy Fox. All in favor. Motion Passes.
