AN ORDINANCE AMENDING COLE CAMP MUNICIPAL CODE SECTION 230.030: COLLECTION OF SOLID WASTE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLE CAMP, MISSOURI, AS FOLLOWS:

1. Section 230.030 (Ordinance No. 185 and Ordinance No. 244) is hereby revoked and the following is enacted in lieu thereof:

Section 230.030: Collection of Solid Waste

A. The City shall provide for the collection of solid waste as follows:

1. *Collection of residential solid waste.* The City shall provide for the collection of residential solid waste in the city, provided however, that the City may provide the collection service by contracting with a person, County or other City or a combination thereof for the entire City or portions thereof as deemed to be in the best interest of the City. Each single-family resident and each family of multi-family residences shall be provided residential solid waste collection services on a weekly basis and shall pay a monthly fee therefore as provided in Section 230.100.
2. *Other collections.* The City shall provide no commercial solid waste collection service and each commercial establishment within the City shall contract to dispose of its own solid waste. Each such commercial establishment shall dispose of said solid waste in a manner consistent with other provisions of this Chapter in accordance with the laws of the State of Missouri and the United States of America.

B. All solid waste from premises to which collection services are provided under contract with the City shall become the property of the collection agency upon being loaded into the transportation equipment.

1. All solid waste from premises to which collection services are provided by the City shall be collected, except bulky rubbish as defined herein, provided however, that bulky rubbish will be collected if tied securely in bundles not exceeding reasonable limitations of weight and bulk to be fixed by regulations to be made and promulgated by the Director as hereinafter provided. All solid waste collected shall, upon being loaded into transportation equipment, become the property of the collection agency.
2. Tree limbs and yard wastes, as described in Section **230.020** (E) and (F) respectively, shall be placed at the curb or alley for collection. Solid waste containers as required by this Chapter for the storage of other residential solid waste

shall be placed at the curb or alley for collection. Any solid waste containers, tree limbs, yard wastes, or other solid waste permitted by this Chapter to be placed at the curb or alley for collection shall not be so placed until the regularly scheduled collection day.

- C. Solid Waste containers as required by this chapter for the storage of residential solid waste shall not be placed at curbside until 8:00 A.M on the day preceding the regularly scheduled collection day. Containers shall be removed from curbside no later than 8:00 A.M. the following day of collection. No alley service shall be allowed under the terms this Chapter, except as approved by the Board of Alderman.
- D. Bulky rubbish shall be collected by the City in the spring of each year at a date to be set by the City which date shall be announced in advance to the residents by publication in the local newspaper. Such collection shall be at no cost to City residents.
- E. Solid waste collectors, employed by the City or a solid waste collection agency operating under contract with the City, are hereby authorized to enter upon private property for the purpose of collecting solid waste therefrom as required by this Chapter. Solid waste collectors shall not enter dwelling units or other residential buildings for the purpose of collecting residential solid waste. Commercial solid waste may be removed from within commercial establishments upon written request of the owner and approval by the Director.
- F. It shall be the responsibility of the occupants of each dwelling unit to prepare, package and deliver solid waste to curbside for collection as prescribed in this Chapter and as it may be amended from time to time.
- G. It shall be the responsibility of each commercial, industrial, institutional or other non-residential generator of solid waste to prepare, package and store solid waste so generated as prescribed by this Chapter and as it may be amended from time to time.
- H. It shall be the responsibility of every solid waste collector to abide by this Chapter and receive and transport solid waste in a manner consistent with the provisions of this Chapter.
- I. The following collection frequencies shall apply to collections of solid waste within the City: All residential solid waste, other than bulky rubbish, shall be collected at least once weekly. At least one hundred forty-four (144) hours shall intervene between collections. All commercial solid waste shall be collected once weekly and shall be collected at such lesser intervals as may be fixed by the Director upon a determination that such lesser intervals are necessary for the preservation of the health and/or safety of the public.

- J. Residential solid waste containers shall be stored upon the residential premises. Except as provided in Subsection **(C)** hereof, all solid waste containers stored out-of-doors shall be stored behind any building located on the tract of land. Commercial solid waste containers shall remain in the location from which they are to be serviced except while being serviced. Commercial solid waste containers shall be stored upon private property, unless the owner shall have been granted written permission from the City to use public property for such purposes. The storage site shall be well drained; fully accessible to collection equipment, public health personnel and fire inspection personnel.
 - K. All solid waste collectors operating under contract with the City or otherwise collecting solid waste within the City limits shall be responsible for the collected solid waste from the point of collection to the point of disposal, provided the solid waste was stored in compliance with the applicable Sections of this Chapter. Any spillage or blowing litter caused as a result of the duties of the solid waste collector shall be collected and placed in the transportation vehicle by the solid waste collector.
 - L. It shall be unlawful for any person, firm or corporation collecting and disposing of rubbish, garbage or waste material from premises in the residential districts or premises in any commercial district which abuts or adjoins a residential district in the City to make such collection or dispose of rubbish, garbage or waste materials between the hours of 9:00 P.M. and 5:00 A.M.
2. All Ordinances or parts of Ordinances in conflict herewith are hereby amended to conform to this Ordinance.
3. That this Ordinance shall be in full force and effect upon its approval and passage.
