Camera's: Mayor Burdick described the camera and audio system that were purchased, and the location where the cameras are located.

Request for Qualifications (SS4A Grant): The city received RFQ's from three companies for the opening of SS4A Grant. The companies are Bartlett & West; Great River Engineering, and CFS Engineers. Saben Yanez with CFS addressed the alderman about their company's interest in the project. The city will decide at the next meeting which company to choose.

Equipment Lease Purchase Agreement Payoff: The Equipment Lease Program was discussed. Steve Knox moves to pay off the Equipment Lease Program in full with a second from David Locke. Roll Call: Mindy Fox – Aye, Steve Knox – Aye, David Locke – Aye, Jeremiah Crider – Aye. Motion Passes.

Committee Report: Planning & Zoning committee reported that they had the public hearing for rezoning from R-1 to AG. P&Z recommends to the city rezone the piece of property.

Clerk Report: Ms. Paul asked the aldermen to bring in their code books to the office to be updated with the new inserts. She also mentioned codification for the city code. She asked for permission to contact the school and museum to remove historical items from the city hall. Dawn asked to have the office closed on Saturdays due to the Aldermen's request for no overtime for city employees. A consensus of the alderman was to close the office on Saturdays. She also talked about the MML conference she attended.

Public Works: Public Works Director Heath Roark notified the aldermen that Derek Dieckman has passed his 90-day probation. Steve Knox moves to have Derek Dieckman full-time with a second from Mindy Fox. All in Favor. Motion Passes. Steve Knox asked about lift stations. Trent Root will be in the city on Monday to talk about the Lift Station. The public works had a thank you for the job they did on Ferguson St.

Police Report: Police Chief Canfield told the aldermen that the police department had 177 hours total with the police and contract officers for the Cole Camp Fair. The sheriff's department also sent 2-3 officers nightly to the fair. Chief Canfield asked the aldermen to consider changing and or throwing out the UTV & golf carts ordinance. The city attorney will email Chief and the aldermen a draft ROV/Golf cart ordinance to look at. He also brought up the city has an ordinance stating all streets going onto Butterfield Trail will come to a complete stop. There are a few streets that do not have stop signs. The alderman asked to have the signs placed. The city ordinance says we have a 4-way stop a Maple and Junge. The mayor suggested a portable stop sign in that location. The city can order signs from MO Vocational Enterprises.
