Clerk Report: "Windows" Council asked to put out bids for window replacement in the newspaper. "Website" Ms. Paul brought the information of Streamline, a website for the city, to the council. The cost of the website would be \$355.00 monthly. We will add this to the agenda in September. "ARPA Account" Ms. Paul asked permission of the council to close the ARPA Bank Account in the amount of \$232,423.51 since the city has spent \$225,891.05 in supplies for the water project. The ARPA funds were previously voted to use for the water project. Jon Beckman motions to close the ARPA Bank Account and move the funds to the Water Fund-Utility Line Addition with a second from David Locke. All in Favor. Motion Passes.

**Mayor Report:** Mayor Meuschke talked about the Cole Camp Fair. The mayor signed the contract with CO-MO Connect. Provincial and CO-MO came to an agreement and will be going aerial. A meeting is scheduled with the engineers and CO-MO on Monday, August 21, 2023.
